Professional Fundraiser Hired by OOEC

The Owasippe Outdoor Education Center, a Michigan 501c(3) corporation, has hired Gordon Zion, a professional fundraiser, to help with the final push to purchase Owasippe Scout Reservation and turn it into an "Outdoor University" to provide a world-class outdoor education experience for youth and adults.

A former professional Scouter himself, Zion helped raise millions of dollars for the Chicago Area Council years ago. For the past 15 years, he has helped create successful economic development campaigns in many cities and counties across the United States, including Spokane, Des Moines, Kalamazoo and Sioux Falls. His efforts have included raising large endowments for communities, colleges and business districts including some in West Michigan.

"By way of introduction," Zion says, "I was a professional with the CAC for nine years and a camp director at Owasippe for two. Watching a ladybug climb a milkweed stalk, a chipping sparrow search for food, the sound of a cricket at night and the soaring flight of an eagle. Are those experiences of mine, and hundreds of Scouts, to be lost for generations of young people? The Owasippe Outdoor Education Center says no."

Zion had identified the three-level effort needed to accomplish raising the funds needed to buy Owasippe and the estimated percentage that each level is expected to make up of the final funds raised.

1) 70-75% of total funds - Buy-in of major opinion setters who will not only endorse the effort but will provide major dollar leadership. This group will establish a level of expectation for other interested parties. This level will also appeal to those who would respond to the "naming right" of specific project proposals.

2) 20-25% of total funds - A second level would be potential "users" of the center willing to buy in to the process in order to assure their use of the facility.

3) 5-10% of total funds - And lastly, to the alumni of Scouts and Scouters. Building a base of support by their numbers that not only campaign success and endorsement will be clear but also participation in program delivery will be assured.

We look forward to working with Zion and the success we believe he can help us bring! Zion served nine years as an executive in the Boy Scouts of America responsible for capitol development. Campaign pressure doesn't faze Zion because he served as a senior radar/air-traffic controller during a four-year hitch in the Air Force.

Zion's salary will be paid by funds raised thus far as part of the Save Owasippe Scout Reservation efforts. The fund has almost \$74,000 in it. Joe Sener covered other sources of major funding at a rally and informational evening on October 1. Promising contacts have been made in West Michigan through the help of prominent residents, government officials, and business leaders. Another possibility the OOEC is applying for is the Michigan Natural Resources Trust Fund, for which we seem to meet the main requirements. The only limit on how much this fund may provide is set at 75% of the purchase price. We will keep updates coming on fundraising efforts.

Please continue to share contacts and possible resources with Joe Sener or any member of the OSA board. And we encourage holding fundraisers and gathering donations for the SOSR fund being held by the OSA.

In the last issue, I announced the conclusion of the OSA 40K project series. I also promised a recap of our 40K accomplishments.

First, a little history. Back in 1999, the OSA Board began talking and brainstorming about taking on the largest fundraising goal to date. After much deliberation and planning, the sum of \$40,000 was settled on and the campaign was dubbed the OSA 40K drive. From there we cranked up the PR engine and started a grassroots campaign to reach our goals. We wrote letters, published articles, held special meetings and we even conducted a phone-a-thon.

When the dust settled, we had raised close to \$38,000 in donations of cash and building materials for various projects. Materials included lumber (from Sterling Lumber) and hot water heaters (from Columbia Pipe) just to name a couple. We also had special memorial funds added to our efforts in the name of Chuck Nagel and Christopher Hill.

40K accomplishments included the re-roofing of every staff cabin on the reservation, hot water heater installation in every Carlen KYBO, the complete refurbishing of the Wolverine and Blackhawk firebowls the construction of the Charles F. Nagel Memorial COPE Base and the construction of the Christopher Hill Memorial Climbing tower.

Not too shabby eh? Thanks to all who made the OSA 40K such a hugely impressive success!



Fall Fix-it Recap

Thanks to all who attended the Fall Fixit. 60 or so workers completed a variety of tasks. Projects included re-roofing one Blackhawk KYBO and one Reneker cabin, fully repairing one badly damaged sailboat, sanding a ton of oars to prime and paint next time, painting Blackhawk KYBO interiors, moving more sand to the Blackhawk firebowl and installing a few more check-dams, installing waterproof paneling in the Wolverine showerhouse, and drywalling the ceiling of a Food Prep storage room.

Following the day's work, everyone gathered at the Christopher Hill Memorial Climbing Tower for its dedication. A number of adventurous people climbed the new tower including Monique Tripp, Chris's mom. Dinner was awesome (thanks to the kitchen crew!), and Joe Sener provided a summary/update of the SOSR campaign. Also present at dinner were the White Lake Area Chamber of Commerce and members of the Owasippe Conservation Club. This Fixit marks the first time the OSA and the OCC worked side-by-side at a Fixit, and we look forward to more collaboration between the two groups for the greater benefit of Owasippe. Thanks again to everyone!

Sale of Hoover Approved

The Board of Directors of the Chicago Area Council voted to approve the sale of Hoover at its quarterly meeting in mid-October. The presentation of the proposed sale was made by a consultant who has been working with the council for some months and by Lew Greenblatt, Council President.

The offer consists of a number of key points:

1. The property is to be sold in three parcels, essentially comprising the East, Central, and West fields and transferred over the course of the next two years and will remain green space for recreational and conservation use.
2. The buyer will be a conservation holding company that is acting on behalf of Kendall County Forest Preserve District. The two years reflects the need to manage the cash flow from federal and county funds.
3. CAC will be able to use the property for at least the next three years (yet to be negotiated) but expects to be able to negotiate beyond that three-year limit. The Boy Scouts will be able to use the property on a cash-for-use basis.
4. The sale is expected to be negotiated and closed by late November (according to Greenblatt.)

The vote was held and passed by a 21 to 6 margin. It is not clear how the "continued use" clause is or will be worded. While the properties committee believes that the CAC will be permitted to use the property going forward, the actual fees for use have not been negotiated.

There was not plan presented as to how the money received from the sale would be used beyond a discussion that an endowment would be set up with the interest being used by the Council. Greenblatt agreed to set up an ad-hoc committee, to be set by Mark Linse and Jim Stone, to review the business plan on how to use the proceeds from any investment. The committee will report to the Board at the next meeting.

With this vote, Greenblatt as Council President is authorized to conclude negotiations and contract for the sale of Hoover without further review or discussion by the board.

Up a creek... (Owasippe Memories)

Where do you start with over 30 years of camping and loving Owasippe? I guess I should start with my first summer at camp, 1968. I was new to Scouting, to being married to David Lavine, and of course new to Owasippe. When Family Camp had a sign up for a canoe trip, of course, I signed on.

I had not been canoeing for many years but because of size, strength and experience, I paddled stern. My bowman (or should I say bow-woman) had never been in a canoe before. We also had, sitting in the middle, one of the younger kids at Family Camp. On the river, there are so many trees with branches growing out over the river, presenting a bit of a hazard to the inexperienced. I saw one VERY low branch and hollered, "DUCK." I shipped paddle and took my own advice. Suddenly something brushed by my ears, and as I looked up, I saw that I had lost my bowman. It seems that when I said duck, she looked up and grabbed the branch. What had brushed by my ears were her feet!

David had had an experience with a Troop canoe trip. He always took the least experienced boys in his canoe. One of the Scouts had lost his paddle and was reaching out for it. Dave did not have enough time to compensate for the weight all going to one side, the canoe tipped and they all went into the water. The rest of this story is as it was relayed to me by the SPL. "Mr. Lavine came up out of the water with seaweed all over him, looking like Neptune arising from the

deep. His first words (after he saw that the Scouts were ok) were 'Where are my cigarettes?'"

Our kids always told their dad that he exaggerated. One of the years at Camp Blackhawk (GO), Dave had seen what he described as the granddaddy of all skunks. Our oldest son, of course, did not believe him until the evening of closing campfire. Butch (David Jr.) had stayed back at the site to start loading the trailer for an early departure the following day. When we got back to the campsite, Butch stated that he really owed dad an apology. As he loaded gear into the trailer, granddaddy skunk decided to pay one more visit to the site. He was friendly enough and did not spray, but he surely had Butch worried for a bit.

One year at Owasippe, Dave had a friend of one of his Scouts with the Troop. The boy was from France and knew very little English. The whole idea of his spending the summer in the U.S. was to learn more English. He came home from camp with a very proficient "Boom-chick-a-boom."

Each year at Owasippe was special to both Dave and me, as well as our kids. Someone had asked Sara if she didn't resent our time in Scouting and she answered that if it wasn't for Scouting, she wouldn't be on staff and having such a great time. By the way, Sara had spent so many of her birthdays at OSR that she was 5 or 6 before she found out that there was another Happy Birthday song other than the one she had always heard at Owasippe.

Dearest Angela,

Here I sit in the hospital (not sick however). Doc and I are alone here this evening, everybody else having either gone to Chicago or in to town. Everything is so darn spooky here that I think I'd go goofy if I had to stay alone without Doc here. This is giving me a lot of time to write to you.

I didn't go to the Family Camp party the other night because I needed sleep too bad to stay out late at night. I can forget about all this other stuff if I have you to think about and your letters to read over again. And maybe you don't think I missed your letter in the mail today and tomorrow there isn't any deliveries in mail. Boy, if there isn't a letter from you Monday, I'll go thru the roof of our cabin in one leap. I know I missed a day, but as I wrote in my last letter it was unavoidable because I was so busy from the morning of Thursday 'till the morning of Friday. It was just by luck I got off the letter yesterday.

It seemed funny, as I was sweeping out the cabin (there wasn't anything else to do here) for Mass in the morning, that I should have found my plans for tonight end so funny or might I say so lonely. I wonder what you're doing now?

I sailed alone all afternoon today and I thought I should have been on Lake Michigan in a boat twice as big and not alone but with you. Maybe next period, stayover will find me better situated to leave this place. If you were here I'd just as soon stay all year without ever seeing Chicago. Gosh I don't know why I feel like this, it doesn't happen often that's a cinch.

Mr. Miller the camp director just got back so I'll have to get to work again and I'll sign off now as ever before



The scholarship remembers Steve Schaefer who literally grew up at Owasippe, first as a youngster in Staff Village, then as a camper, and finally as a staffman. Steve was voted CIT of the Year among his many Owasippe staff accomplishments.

In 1989, Steve was killed in a tragic fire while attending Southern Illinois University. Having already saved several of his friends, Steve heroically re-entered the burning building to look for an additional friend that was still believed to be inside. The friend had made it out a back door but sadly Steve did not.

He is remembered fondly and missed greatly. A memorial plaque, in Steve's honor, can be found in the Owasippe Museum.

OSA Joins White Lake Chamber Of Commerce

In September, the Owasippe Staff Association joined the White Lake Area Chamber of Commerce to exhibit its solidarity with the Whitehall and Montague communities, to forge new working relationships, and to publicly proclaim its dedication to the preservation of Owasippe and the culture of Blue Lake Township. The Chamber of Commerce was responsible for getting Owasippe its start in 1910 with a donation of 40 acres of land on Crystal Lake (aka Owasippe Lake).

Blue Lake Fire Get Upgrades


The Blue Lake Township Fire Department is getting some new equipment, thanks to their portion of a \$752,075 grant from the U.S. Department of Homeland Security. The money was divided among 19 fire departments across the state of Michigan.

Blue Lake will use its \$20,000+ to buy extra personal protection devices for the 14 part-time paid staff, add new equipment to the vehicles owned by the department, upgrade radios and acquire a thermal imaging camera. Part of the grant will be used to provide hoses, nozzles, fittings and adaptors so the Blue Lake Fire Department will be better able to work with other fire departments in the area. Currently, they may have different fittings, making it difficult to interchange equipment.

SCBA bags and helmets with prescription lens inserts along with personal rescue escape ropes and hand-held radios are on the shopping list. The thermal imaging camera allows fire personnel to scan a smoke-filled space and find "hot spots" that might otherwise be concealed from view inside a structure.

The Blue Lake Fire Department is just a little further up Owasippe Road past Camp Blackhawk.





It's OSA Ad Book time again!
