Judge Rules for Blue Lake Township

Judge Marietti ruled in early March in favor of Blue Lake Township on all counts in the zoning lawsuit brought by the Chicago Area Council. The 19-page ruling (available on www.OOEC.org under News & Updates) was released on March 6. The ruling is packed with Marietti's summaries, including that the 2002 zoning amendment to change the camps from FR to FRI didn't prohibit any uses of the property, that the land is a gem of Michigan, that the FRI zoning serves the public good, and that other camps in the area under the same zoning are thriving. In one portion of the decision focused on the factor of economic impact, Marietti cites Stone's testimony that CAC was losing money before the change in zoning, so FRI zoning is not to blame for CAC's continued deficits. Marietti also squarely supports the township's appraisal of \$12.3 million as currently zoned - vs. the CAC's appraisal of \$2.3 million - and discounts the CAC's appraisal on numerous counts. Marietti writes, "Based upon the findings that there was neither a denial of substantive due process as applied nor an unconstitutional taking, this Court declines the invitation to thwart the will of the public as expressed through the Township board."

This ruling is fantastic news for the Save Owasippe efforts. A decision in favor of the CAC would have been the next step

toward the sale to developer Ben Smith becoming a reality. But we're not out of the woods yet. The CAC Executive Board met on March 20 and voted 15-5 to pursue an appeal of the decision. Before that vote was taken, council attorney Devin Schindler presented his opinion that an appeal would not cost as much (estimates place the bill to the council thus far at \$1 million). Considering this first suit was filed in 2006 and not decided until 2008, we have a long road ahead of us.

On the flip side, Blue Lake Township has spent about \$250,000 to defend itself in the Owasippe case, and has filed a request with Marietti to order the council to reimburse the township for some of its costs.

At the same March 20 meeting, Charles Dobbins was officially installed as Interim Scout Executive, replacing Jim Stone who is set to retire June 1. Dobbins reportedly has taken the position of Scout Executive immediately. He most recently served as Associate Regional Director of Endowment. In a former position, he oversaw the merging of the Sinnissippi Council in southern Wisconsin/northern Illinois and Four Lakes Council in Madison, Wisconsin. Also National Council of the BSA has given the CAC a "provisional charter" to operate as a council - a move that has been described as putting the council on probation, according to council members. ♣

OOEC Names Major Backer

In March, the Trust for Public Land (TPL) announced its relationship with the Owasippe Outdoor Education Center. The national conservation group helps broker land deals with preservation in mind. According to the Muskegon Chronicle, the TPL reported \$220 million in revenue for its 2006-07 fiscal year on its 2006 federal tax filing. It is a national nonprofit land conservation organization based in San Francisco that since 1972 has preserved 2 million acres in 47 states valued at \$4 billion. It conserves natural places, parks, community gardens, historic sites, farms and ranches.

The OOEC and TPL have been working together privately for months lining up details of a possible purchase of Owasippe. TPL could provide a loan to the purchaser, or

CAC Slates Defeated... Again

In another round of CAC elections, all slates were squarely defeated at the April 2nd annual meeting. Though slates weren't even announced until four days before the election, Chartered Organization Representatives arrived at the 5 p.m. meeting downtown Chicago and voted solidly against all five slates. The slates for Board of Directors, Advisory Board and Executive Officers were defeated by a margin of more than three to one. Council Representatives and Member At Large slates were closer, being defeated by a roughly two-to-one margin.

Many believe one of the contributing factors to the rejection of the slates was the removal of Jim Adamitis in exchange for Brian Kasal. Kasal had been identified as a

it could finance the deal and hold the property until it was reimbursed by grants, private funds and organizations. It has brokered land conservation deals in many forms and wants to work with the OOEC to purchase Owasippe in its entirety from the CAC.

Though the council has yet to publicly let membership know if they are willing to consider a sale to the TPL/OOEC partnership now that the TPL has added its credibility to the deal, the OOEC's \$12.3 million offer stands as the only offer on the table aside from Ben Smith's \$19 million offer, which is contingent on rezoning away from FRI.

Another of OOEC's backers, the Rosa and Raymond Parks Institute, would still be a major part of the funding and use of the camp if the deal can be made. All three groups share a common goal of outdoor education as well as protecting and preserving tracts of natural land. ♣

"lightning rod" and was removed from the council governance during the reorganization following the Scouter-11 lawsuit. Many CORs still view Kasal as a lightning rod for negative action, whereas Adamitis is viewed as a frontline Scouter.

Council has set June 2nd as the date (5 p.m. at the same location as last meeting) for the reconvened annual meeting. By then, the nominating committee can adjust the slates or simply re-present the same slates (and hopefully announce them further ahead of time). Council President Mike Hughes presented a long-term plan for a reduced-size camp Owasippe, keeping just 1,000 acres and moving all activities and facilities as needed. The plan was met with jeers from the frontline Scouters present.

The site also pulls current news, has an interactive map, and lists ongoing improvements downtown as part of the Cool Neighborhoods revitalization plan. A business directory is available on the site so you can call ahead to check with individual businesses for hours or special events. You can sign up for email updates as well. Restaurant News in Whitehall

Attention all camp staff! Gary's is moving! The favorite breakfast destination for staff week and throughout the summer is planning a move to the old location of Ciabatta's (also past location of Michael's, The Sands, Diamondback Steakhouse and more), across Colby Street from Pizza Hut. They plan to be in the new digs by June 1 and may begin serving dinner as well as breakfast and lunch.

Also, Harbor View Grille is planning to open in late April. The restaurant, located behind Bell's Furniture in downtown Whitehall, overlooks White River and White Lake and plans to serve lunch and dinner. The menu is moderately priced, with burgers and sandwiches starting at \$6 and complete meals between \$8 and \$13. Weekly specials are also planned.

In a final piece of dining news, Crosswinds is again gearing up to reopen. The owner has worked out the liquor license, and she expects to be open in time for tourist season. There is little news at to whether it will be a similar menu as before (you may remember it was sold and reopened as Scales for a time), but the location with the dining deck right on White Lake is sure to draw customers. Happy dining!

Rothbury Fest

A huge concert is landing in Rothbury, just five minutes north on US-31 from Whitehall.

Rothbury Festival includes big-name musicians like Dave Matthews Band, John Mayer, Widespread Panic, 311, Primus, Modest Mouse, Snoop Dogg and dozens more. The event will happen July 3-6 at the Double JJ Ranch. One of the major focuses of the concert event is environmentalism, so much of the planning includes green-centered policies. There will be multiple stages, a marketplace, and think tanks for green awareness information. Plans currently state that guests will park their



cars and be shuttled around the facility to reduce emissions. Proceeds for the show will go to outfit a Rothbury school with solar panels to provide lasting energy replacement and as a bonus to the town of Rothbury for hosting the event.

Tickets are on sale now and run from \$100 for RV passes to \$250 for a full weekend ticket including campsite to \$475 for concert ticket and cabin lodging. Silversides Adding Museum

One of the popular outpost attractions at camp is an overnight stay on WWII submarine USS Silversides. Now the sub is getting a brand new building to house related Navy and WWII-era artifacts, many of which have been stashed away in storage areas for lack of space to display them. A new \$2 million channel-side museum is scheduled for opening in mid-June, rounding out a visitor destination center that is expected to attract more than 50,000 visitors annually. Besides bringing the Silversides' propellers and torpedoes and other outdoor exhibits in out of the weather, the sizable 16,500-square-foot museum building will properly display an actual control system taken from a nuclear-powered incarnation of the USS Silversides, since its decommissioning. Acquisition of a nuclear submarine periscope to go with it is in the works. And besides adding greatly to exhibit space, the recently christened Robert G. Morin Sr. Building will include two exhibit areas, a research library, classrooms, a 72-seat theater, on-premise storage space for artifacts, offices, a banquet and conference area overlooking the Muskegon Channel and an expanded gift shop. It also will have a staging area for tours and for those participating in the museum's popular Overnight Encampment Program before going aboard the submarine or the Coast Guard cutter for the night.
